## **Terms and Conditions**

### **1. Introduction**

Lendermarket offers the opportunity to earn a bonus by investing newly deposited funds. The terms used herein shall have the same meaning as described in the [Rules of the Platform](#) unless the context otherwise requires or is indicated differently in these Terms.

- 2.3. **('Depositing Period')** from 11 November 2025 at 00:01 UTC to 21 November 2025 at 23:59 UTC (both inclusive).
- 2.4. **('Investing Period')** from 11 November 2025 at 00:01 UTC to 21 November 2025 at 23:59 UTC (both inclusive).
- 2.5. **('No Withdrawal Period')** from 11 November 2025 at 00:01 UTC to 2 March 2026 at 23:59 UTC (both inclusive).
- 2.6. **('Bonus Pay')** The bonus will be credited by 12 March 2026 at 23:59 UTC.

### **3. Eligibility criteria**

- 3.1. The User will receive a fixed €111 bonus if all conditions set in these Terms have been fulfilled.
